#### Second edition of the European Tertiary Education Register (ETER)

ETER is the only Europe-wide compilation of comparable data about individual higher education institutions, covering more than 2,200 universities and colleges in Europe. It provides detailed data on 2,293 higher education institutions hosting more than 17 million students. Covering 31 European countries, the data include university size, number and gender of students and staff, subject areas and degree levels, as well as information about research, international students and staff, and funding. It aims to help policymakers to manage their higher education systems, and to enable universities to compare themselves with others and identify opportunities for research collaboration or specialisation. <a href="http://eter.joanneum.at/imdas-eter">http://eter.joanneum.at/imdas-eter</a>.

#### **Eurydice Brief: Early Leaving from Education and Training (ELET)**

Published by Eurydice, the report shows that collectively Member States are getting closer to the EU headline target: by 2020, the share of early leavers from education and training (aged 18-24) should be less than 10%. Nevertheless, ELET remains still a serious challenge in many EU countries. Even if all countries have put in place measures to fight against early leaving, only a few have so far developed a specific ELET strategy, integrating prevention, intervention and compensation measures. The report also looks at how education, career guidance and cross-sector cooperation play an important role. It covers all the EU Members States as well as Iceland, Norway, Switzerland and Turkey. The reference year is 2013/14.

## EEA Photo Competition "Picture 2050 – Living well within the limits of our planet"

Launched by theEuropean Environment Agency (EEA), the competition invitesparticipants to share their views on Europe's environment. Participants should be 18 or older and be citizens of the <u>EEA member countries and West Balkan cooperating countries</u>. They will have to submit a personal or a generic story, consisting of three photographs, depicting their vision, interpretation or understanding of 'living well, within the limits of our planet in 2050' along the three objectives of the <u>The Environment Action Programme</u> (7EAP):

- .Natural capital.
- Resource-efficient, low-carbon economy; and
- Human health and well-being.

One entrant may submit maximum five entries (an entry consists of a set of three pictures). The winners will be awarded cash prizes of EUR 2,000 for the 1<sup>st</sup>prize, EUR 1,500 for the 2<sup>nd</sup>prize, EUR 1,000 for the 3rd prize and EUR 500 for the Public Choice award and the Youth Prize. The Youth Prize will be awarded to the winning entry, selected among those submitted by persons aged between 18 and 24 (born between calendar years 1991-1997). All the finalists will be put forward for the Public Choice Award and may also feature in future digital and print material from the EEA and its European partners.

#### Lorenzo Natali Media Prize 2015

Launched by the European Commission, the prize rewards outstanding contributions made by journalists reporting on development, and in particular on the eradication of poverty. Under the motto "Today's stories can change our tomorrow" professional and amateur journalists will have to upload their own original journalistic work-either individually or, for jointly authored or produced items, as a group. All entries must have been published (print or online), broadcasted or have appeared in an agency dispatch for the first time between 1stSeptember 2014 and 31stAugust 2015. Only one item or one extract from a series of journalistic works (i.e. one article or one radio/TV piece) can be entered. Entries must have been published in one of five regions: Africa; the Arab World and the Middle East; Asia and the Pacific; Europe; Latin America and the Caribbean and can be submitted in any of the 24 official European Union languages. Journalists are required to submit a summary (between 200 and 400 words) in English.A grand jury will reward one professional and one amateur journalist. The winners will receive trophies and cash prizes of €5,000. Furthermore, the winners will be qualified to win additional €5,000 Grand Prize during an award ceremony in Brussels, Belgium, in December 2015.

### **Highlights**

#### Eurostat release: June 2015 Euro area unemployment rate

According to Eurostat, the statistical office of the European Union, the Euro area (EA19) seasonally adjusted unemployment rate was 11.1% in June 2015, stable compared withMay 2015 and down from 11.6% in June 2014. The EU28 unemployment rate was 9.6% in June 2015, alsostable compared with May 2015 and down from 10.2% in June 2014. In June 2015, 4.724 million young persons (under 25) were unemployed in the EU28, of whom 3.181 million were in the Euro area. Compared with June 2014, youth unemployment decreased by 386 000 in the EU28 and by 225 000 in the Euro area. In June 2015, the youth unemployment rate was 20.7% in the EU28 and 22.5% in theEuro area, compared with 22.1% and 23.6% respectively in June 2014. In June 2015, the lowest rates wereobserved in Germany (7.1%), Malta (10.0%), Estonia (10.1% in May 2015), Denmark and Austria (both 10.3%),and the highest in Greece (53.2% in April 2015), Spain (49.2%), Italy (44.2%) and Croatia (43.1% in the second quarter of 2015).

#### **EUCIS-LLL Erasmus+ Implementation Survey 2015**

Organised by EUCIS-LLL, the survey aims to evaluate what beneficiaries of the Erasmus+ programme think about it, if they are satisfied with its new features, if they encountered problems and what they would suggest to improve it. ## Competences for Democratic Culture: Invitation to take part in testing descriptors

The Education Department of the Council of Europe has developed a new theoretical model of the competences (i.e. the values, attitudes, skills, knowledge and understanding) that are required for democratic culture. Following consultation with international experts on the Model of Competences, the Education Department of the Council of Europeis welcoming feedback from education professionals at all levels on descriptors for these competences. The questionnaire is available in English, French, Russian, Georgian, Italian, Romanian and Spanish. German and Serbian will be added shortly. By answering this questionnaire, contributors will support the development of a framework of reference for democratic culture that will be available for use in educational planning and teaching in the 47 member states of the Council of Europe. #### Almost 30 000 workers supported by the European Globalisation Adjustment Fund during 2013 and 2014

During 2013-2014, the European Globalisation Adjustment Fund (EGF) helped a total of 27 610 workers, who had been dismissed due to the economic crisis and the effects of globalisation, to find new job opportunities. A report adopted on 22<sup>nd</sup> July shows that, during this period, the EGF provided more than €114.4 million to assist workers in 13 Member States (Austria, Belgium, Denmark, Finland, France, Germany, Greece, Ireland, Italy, the Netherlands, Poland, Romania and Spain) in their transition and towards new job opportunities. The EGF funding was matched by another €94.1 million from national resources. The EGF report gives an overview of applications for support measures made in 2013-

2014 and also includes results from a number of cases for which final reports were received in 2013-2014. It shows that half the workers (7,656 out of 15,245) who participated in the EGF measures found new jobs or became self-employed. An additional 667 people were at that time in education or training to increase their future employability. Member States reported that the personal situation, employability and self-confidence of the workers concerned had visibly improved thanks to the EGF assistance and services. The results in terms of re-integration into employment are encouraging, given the difficult labour market situation in most Member States, and considering that the EGF supports workers in particularly difficult circumstances. Many measures concern mass lay-offs in a specific territory, often already suffering from high unemployment rates. It is also to be noted that the supported workers are often low-skilled or had other disadvantages as jobseekers. <a href="http://bit.ly/1DuhAOv">http://bit.ly/1DuhAOv</a>.

New EU logo to help patients avoid online sellers of fake medicines From 1<sup>st</sup> July, all online pharmacies or retailers of medicines legally operating in the EU should display a new logo introduced by the Falsified Medicines Directive to protect patients. Europeans considering buying medicines online should look out for the logo on the webpages of an online pharmacy or other online retailers. The logo has a two-step verification process to ensure maximum protection from falsified medicines, which are usually ineffective, substandard and dangerous. When clicking on the logo, online shoppers should be taken to the national regulatory authority website which lists all legally operating pharmacies and retailers of medicines in a given Member State. http://ec.europa.eu/health/human-use/eu-logo/index\_en.htm
