EU Youth Report 2015

Published by the European Commission, the report draws a full picture of the situation of young people in Europe and how policy-makers have addressed it in the period 2013-2015. It reveals that generally young people are better educated than their predecessors and less young people drop out of school in the EU. Yet, 8.7 million young people aged 15-29 are unemployed, 13.7 million are not in employment, education or training (NEETs) and close to 27 million are at risk of poverty or exclusion. "NEETs" tend to participate less in social activities, vote less and have less trust in institutions. Young people are active users of Internet and social media. Around half are active members of organisations. One in four has been a volunteer.

Languages in Secondary Education: An Overview of National Tests in Europe - 2014/15

Published by Eurydice, the report provides a comparative overview of the national tests in Europe assessing the language competences of secondary school students. The analysis covers aspects such as the increasing importance of national tests in languages, the objectives of the tests, the skills tested, as well as the means developed by countries to ensure consistent and reliable scoring procedures, and the influence of the Common European Framework of Reference for Languages on national tests. The report includes the 28 EU Member States, Iceland, Liechtenstein, Norway, Turkey, Montenegro and Serbia. The reference year is 2014/15.

Your first EURES job - Targeted mobility scheme aims at fostering cross border job mobility and tackle the needs of specific target groups, economic sectors, occupations or countries. The present call for proposals aims to foster the exercise of workers' freedom of movement and test innovative ways to improve the integration of young mobile candidates into the host country. It aims in particular to trigger the development of a "welcoming/integration culture" and to contribute to

1. filling hard to fill vacancies with available youth workforce at EU EFTA/EEA level;
2. developing comprehensive mobility support services in EU EFTA/EEA countries and enhancing the quality of services provided to employers who wish to recruit workers from other EU EFTA/EEA countries;
3. boosting cross border matching and placement services for apprentices and trainees as a critical element to help transition from education to work;
4. addressing labour mobility obstacles.

Proposals should focus on job placements (mandatory item) and also on at least one of following types of placements:

- Traineeships
- Apprenticeships.

Call for proposals (EACEA/25/2015)-EU Aid Volunteers Initiative: Deployment of EU Aid Volunteers

Launched by the European Commission, the first-ever call for proposals for deployment of humanitarian volunteers under its EU Aid Volunteers initiative aims to select, prepare and deploy junior and senior volunteers

who will contribute to strengthening the Union's capacity to provide needs-based humanitarian aid. Furthermore, the call aims to strengthen the capacities of implementing sending and hosting organisations participating or intending to participate in the EU Aid Volunteers initiative.

The call includes two strands:

- A. Apprenticeship placements and deployment of junior professionals;
- B. Deployment of senior professionals and/or joint deployments of junior and senior professionals.

Eligible applicants are all organisations in the field of humanitarian aid, civil protection and volunteer management. Organisations need to be certified to the high standards of volunteer management established under the initiative prior to application.

Trio Presidency Italy-Latvia-Luxembourg - Final Joint Recommendations

In the framework of the EU Youth Conference, which took place in Luxembourg from 21st to 24th September 2015, youth representatives and representatives from member states gathered to adopt the Trio Presidency (Italy-Latvia-Luxembourg) Final Joint Recommendations on "Empowerment of young people for political participation in the democratic life in Europe". The Recommendations are grouped under the following goals:

- Creating a culture of participation at school;
- Involving young people in political decision-making;
- Enhancing policy makers' engagement and commitment with young people;
- Strengthening the role of youth work for political empowerment of all young people;
- Developing youth friendly tools for political participation;
- Developing local and direct democracy;
- Developing alternative forms of participation;
- Increasing synergies and cooperation between different actors.

EU proposal aiming to help 12 million long-term unemployed get back to work

On 17th September, the European Commission proposed guidance to Member States to better help long-term unemployed return to work. Following the relaunch of the [Youth Employment Initiative](#) in May, this is another initiative in the context of the broader economic and social agenda of the Juncker Commission, which seeks to strengthen job creation, economic recovery and social fairness in Europe. There are more than 12 million people in the EU who have been unemployed for over a year. Despite the economic recovery and signs of improvements in the EU labour market, their number doubled between 2007 and 2014, accounting for about half of the total number of unemployed.

The proposal for a Council recommendation foresees that all jobseekers who have been jobless for more than 12 months receive an individual assessment and that they receive a job integration agreement, offering them a concrete and personalised plan back to work before reaching 18 months of unemployment.

The proposal puts forward three key steps:

- Encourage the registration of long-term unemployed with an employment service;
- Provide each registered long-term unemployed with an individual in-depth assessment to identify their needs and potential at the latest at 18 months of unemployment;
- Offer a job integration agreement to all registered long-term unemployed at the latest at 18 months.

The job integration agreement should consist of a tailor-made plan to bring the long-term unemployed back to work. Depending on the existing services in each Member State it can include: mentoring, help with the job search, further education and training as well as support for housing, transport, child and health care services or rehabilitation. It should be delivered through a single point of contact to ensure the continuity and consistency of the support. It should also clearly outline the rights and responsibilities both of the unemployed and of the organisations providing support. The proposal also calls for the active involvement of employers through partnerships with the public authorities, enhancing the range of services they can receive, as well as offering them targeted financial incentives.

Member States can implement these recommendations with the support of the European Social Fund.

EU–China cooperation in the field of youth

China Vice Premier Liu Yangdong and TiborNavracsics, Commissioner for Education, Culture, Youth and Sport, met with participants of the 3rd policy and expert seminar on youth cooperation between the EU and China which took place in Brussels on 14th-16th September 2015.

The theme of the discussions focused on past experiences and perspectives for the future. Participants explored cooperation at four levels:

- between youth organisations at global level;
- at national authorities level;
- between public authorities at local and regional level;
- between youth players at local and regional level.

It was agreed that cooperation around youth is essential, as the young people will build the future of our societies. With a view to make such co-operation activities efficient, it was agreed it would be suitable to enhance mutual information and exchange of good practices amongst the stakeholders involved, and to support contact and partner making between youth organisations. Good steps were made to achieving this through the EU-China Youth Friends link, The China Youth Net Website and the EU Youth Portal. In addition to this, Erasmus+ was cited as a valued resource to stimulate further co-operation.

Eurostat release: August 2015 Euro area unemployment rate

According to Eurostat, the statistical office of the European Union, in August 2015, 4.610 million young persons (under 25) were unemployed in the EU28, of whom 3.131 million were in the Euro area. Compared with August 2014, youth unemployment decreased by 448 000 in the EU28 and by 262 000 in the Euro area. In August 2015, the youth unemployment rate was 20.4% in the EU28 and 22.3% in the Euro area, compared with 21.9% and 23.6% respectively in August 2014. In August 2015, the lowest rates were observed in Germany (7.0%), Austria (10.8%), the Netherlands (11.2%), Denmark (11.4%) and Estonia (11.5% in July 2015), and the highest in Spain (48.8%), Greece (48.3%

in June 2015), Croatia (43.5% in the second quarter 2015) and Italy (40.7%).

Every year the European Commission organises a high level Jean Monnet conference on topics of political importance for the European Union. Ahead of International Interns Day, on 10th November, the European Youth Forum has launched a survey to find out about interns' experiences. Internships can be a helpful step in transitioning from school to the workforce, but often, interns do not have the fairest experience. With 4.5 million young people working at an internship each year in Europe, only 59 percent are paid.

Eurostat release: quarterly data on employment

According to the new data on employment, published by Eurostat, the statistical office of the European Union, the number of persons employed increased by 0.3% in the Euro area (EA19) and by 0.2% in the EU28 in the second quarter of 2015 compared with the previous quarter. In the first quarter of 2015, employment increased by 0.2% in the Euro area and 0.3% in the EU28. These figures are seasonally adjusted. Compared with the same quarter of the previous year, employment increased by 0.8% in the Euro area and by 0.9% in the EU28 in the second quarter of 2015 (after +0.8% and +1.0% respectively in the first quarter of 2015).

Eurostat estimates that, in the second quarter of 2015, 228.8 million men and women were employed in the EU28, of which 151.0 million were in the Euro area. These figures are seasonally adjusted.
